## Bullshead Conservation Ranch Grazing Tender

Ducks Unlimited Canada (DUC) is offering by open tender, the chance to graze the uplands of the Bullshead Conservation Ranch (BCR). This tender will make approximately 1700 acres of land available for grazing.

The following items should be noted to assist you in the bidding process:

1. Summary of land available:

- 1354 acres of native grassland (398 AUM's)
- 79 acres of tame grassland (47 AUM's)
- 270 acres of alfalfa/grass (202 AUM's)

2. The bidder is responsible for viewing the land prior to bidding; foot access only is permitted when viewing the property. To get there, travel south from Dunmore on Eagle Butte Road (paved road adjacent to the CO-OP gas station) approximately 20km's to Twp Road 100. Turn left (east) and travel approximately 4.8 Km 's to Rng road 43 . Turn right (south) and travel approximately 4.8 km , which will bring you to the main gate of the ranch.

Please read all the General Conditions and Special Provisions which are attached to the grazing bid package.
5. In order for the bids to be accepted; the Grazing Management Agreement must be completed in full and signed and returned to DUC on or before the tender closing time. The corresponding

Special Provisions pages along with the Grazing Management Plan must be completed, signed and returned as well.
6. Though this is only a one year tender, there may be opportunity to extend the agreement by an additional 2 years, based on the discretion of DUC.
